ANNOUNCEMENT OF ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds from the Share Offer

- Based on the Offer Price of HK\$0.5 per Offer Share, the net proceeds from the issue of the Offer Shares under the Share Offer to be received by the Company, after deducting the underwriting fees and other expenses payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$35.6 million. The Company intends to apply such net proceeds from the Share Offer in accordance with the purposes set out in the section headed “Statement of Business Objectives and Use of Proceeds” in the Prospectus.

Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 10,517 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS for a total of 2,048,648,000 Public Offer Shares, representing approximately 162.6 times of the total number of 12,600,000 Public Offer Shares initially available for subscription.
- As the over-subscription in the Public Offer is more than 100 times, the reallocation procedure as disclosed in the section headed “Structure and Conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus has been applied and 50,400,000 Offer Shares initially available under the Placing have been reallocated to the Public Offer.
- As a result of reallocation, the final number of Public Offer Shares is 63,000,000 Offer Shares, representing 50% of the total number of the Offer Shares initially available under the Share Offer. The Offer Shares offered in the Public Offer were conditionally allocated on the basis set out in the paragraph headed “Basis of Allocation under the Public Offer” below.

Placing

- The Placing Shares initially offered under the Placing have been slightly over-subscribed. The final number of Placing Shares allocated to 126 placees under the Placing is 63,000,000 Offer Shares, representing 50% of the total number of the Offer Shares initially available under the Share Offer. A total of 47 placees have been allotted five board lots of Shares or below, representing approximately 37.30% of the total number of placees under the Placing. These placees have been allotted approximately 0.53% of the 63,000,000 Offer Shares available under the Placing. A total of 25 placees have been allotted one board lot of Shares, representing approximately 19.84% of the total number of placees under the Placing. These placees have been allotted approximately 0.16% of the 63,000,000 Offer Shares available under the Placing.

- In connection with the Share Offer, the Company has granted to the Placing Underwriter, exercisable by the Sole Global Coordinator (for itself and on behalf of the Placing Underwriter) the Offer Size Adjustment Option.
