### **PROFIT WARNING**

This announcement is made by Furniweb Holdings Limited (the “**Company**” and, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2)(a) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary review of the unaudited consolidated management accounts of the Group for the six months ended 30 June 2019 (the “**Period**”), the Group expects to record a substantial decline in its financial performance and anticipates to report a net loss for the Period of approximately RM4.2 million as compared to the net profit of approximately RM0.6 million for the corresponding period in 2018.

The Group’s profitability for the Period was mainly affected by the following factors:

- (i) increase in marketing and distribution cost as the retail business of the Group commenced operation in the second quarter of 2019; and
- (ii) increase in administrative expenses due to (a) professional fees incurred for the acquisition of Meinaide Holdings Group Limited, which was completed on 28 June 2019, and (b) pre-operating and administrative expenses incurred during the Period for the retail business of the Group.

The information contained in this announcement is based on the preliminary assessment by the Board mainly with reference to information currently available, including the unaudited consolidated management accounts of the Group for the Period, which is yet to be finalised and has not yet been audited or reviewed by the auditor of the Company. As such, the actual financial results of the Group for the Period may be different from what is disclosed in this announcement.

**Shareholders and potential investors are advised to read carefully the interim results announcement of the Company for the Period which is expected to be published in or around mid-August 2019.**

**Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**
